He has experience with multiple industries including aerospace and defense, telecommunications, professional services, information technology, higher education and non-profits, and healthcare. Prior to joining Chess, David worked with a regional accounting firm; and previously was the Director of Internal Audit and Compliance, and Ethics Officer at a mid-sized public company. During his time as Director of Internal Audit and as Ethics Officer, he established policy and procedures for the Ethics Office, oversaw corporate compliance in coordination with General Counsel, and led the Internal Audit Function.

## **Professional Experience**

#### **Government Contracting Advisory Service:**

- Emerging Contractor Services. Mr. Dishmon has worked with contractor management to prepare for SF 1408 Pre-Award Surveys and develop/review provisional and forward pricing indirect rates for compliance. He has assessed controls, provided recommendations to address gaps identified, and provided counsel to management as recommendations were implemented. He also assists contractors with contract closeout/quick closeout strategies with government agencies.
- Cost Allowability. Mr. Dishmon has evaluated client accounting records to assess cost allowability in
  accordance with FAR Part 31 Contract Cost Principles and Procedures and other agency supplemental
  regulations. In this regard, he has developed audit plans and managed audits of Incurred Cost
  Submissions including Home Office allocations for adequacy and compliance, including allowability of
  cost
- Cost Accounting Standards. Mr. Dishmon has advised clients on CAS related issues. He has developed general dollar magnitude and cost impact packages for submission to DCMA and DCAA. He has assisted contractors in evaluating the impact of potential accounting changes on their cost structure, including the assessment of impact on contract costs.
- Compliance Reviews. Mr. Dishmon has performed internal audits / gap assessments of contractor business systems. He has managed audits of estimating, budget and planning, accounting, purchasing and compensation systems to verify compliance with applicable regulations (e.g., TINA, FAR, CAS, FCPA), and reported results and recommendations to senior management. Additionally, he has performed reviews of business system controls, and assisted with the creation of control definitions and objectives to comply with government contract regulatory requirements in support of ERP system implementations. He has also provided guidance and support to general counsel on federal regulatory matters including GSA Schedule compliance.
- Claims Pricing and Support. Mr. Dishmon has prepared requests for equitable adjustment. He analyzed
  cost impacts of changed work and prepared claim pricing support. He has also prepared pricing support
  for terminations for convenience.

- Higher Education and Non-Profits. Mr. Dishmon has worked with entities to prepare incurred cost submissions, evaluate business system controls for compliance with Title 2 CFR Part 200 Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards, and assess their cost accounting methods for CAS compliance. He also assisted in the investigation of financial misconduct by a rogue employee in connection with government contracting activity.
- Organizational Conflicts of Interest Assessments. Mr. Dishmon has led teams conducting independent review assessments of organizational conflicts of interest (OCI). These reviews consisted of assessing internal corporate OCI policies, special contract requirements (specifically Centers for Medicate and Medicaid contracts) and FAR guidance to ensure complete OCI compliance within government contractor operations.
- Outsourced Government Contract Compliance. Mr. Dishmon has assisted clients with the management of their government contract compliance function, assisting in areas such as coordination with government auditors/DCAA, internal business system evaluations, audit preparation, completion of indirect cost proposals, and provisional/forward pricing rate packages.

- Business Risk Management / Internal Audit.
